**AUTHORIZING THE PURCHASE OF FIREFIGHTING EQUIPMENT AND
RESCUE TOOLS FROM NEW JERSEY FIRE EQUIPMENT CO. THROUGH
THE BERGEN COUNTY COOPERATIVE PURCHASING PROGRAM**

WHEREAS, the Borough of Kinnelon has a need to purchase firefighting equipment, fire hose, nozzles, adapters, fittings, tools and related equipment for use by the Kinnelon Volunteer Fire Company; and

WHEREAS, New Jersey Fire Equipment Co., 119-131 Route 22 East, Green Brook, New Jersey 08812, submitted Quote No. 35567, dated August 18, 2026, for the requested equipment in the total amount of \$54,742.31; and

WHEREAS, the equipment is available through the Bergen County Cooperative Purchasing Program under Bergen County Bid No. BC-BID-26-16, "Firefighting Equipment and Rescue Tools," awarded pursuant to Bergen County Resolution No. 562-26, with a contract term of May 5, 2026 through May 4, 2028; and

WHEREAS, the Borough is authorized to make purchases through properly awarded cooperative purchasing agreements in accordance with applicable New Jersey public procurement laws and regulations; and

WHEREAS, the Borough's Qualified Purchasing Agent has reviewed the proposed purchase for compliance with applicable procurement requirements; and

WHEREAS, the Chief Financial Officer has certified, or shall certify prior to the issuance of a purchase order, that sufficient funds are available for this purchase.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Kinnelon, County of Morris, State of New Jersey, as follows:

1. The purchase of firefighting equipment and rescue tools from New Jersey Fire Equipment Co., pursuant to Quote No. 35567 dated August 18, 2026, in an amount not to exceed \$54,742.31, is hereby authorized.
2. The purchase shall be made through Bergen County Cooperative Purchasing Program Bid No. BC-BID-26-16, "Firefighting Equipment and Rescue Tools."
3. The Mayor, Borough Administrator, Chief Financial Officer, Qualified Purchasing Agent, Borough Clerk and other appropriate Borough officials are hereby authorized to execute any documents and take any actions necessary to effectuate this purchase.
4. This Resolution shall take effect immediately.
