**AUTHORIZING THE PURCHASE OF A 2026 FORD F-150 FOR THE
DEPARTMENT OF PUBLIC WORKS FROM ROUTE 23 AUTOMALL
LLC THROUGH THE BERGEN COUNTY COOPERATIVE
PURCHASING PROGRAM**

WHEREAS, the Borough of Kinnelon has a need to purchase a pickup truck for use by the Department of Public Works; and

WHEREAS, Route 23 Automall LLC, 1301 Route 23 South, Butler, New Jersey 07405, submitted a proposal dated August 12, 2026, Quote ID KINNW3L2, for one (1) 2026 Ford F-150 4x4 SuperCrew Cab XLT, including specified options and equipment, in the total amount of \$67,383.40; and

WHEREAS, the proposed vehicle is available through the Bergen County Cooperative Purchasing Program under Bergen County Bid No. BC-Bid-24-43, "Car, Crossovers, Class 1-3 Pickup Trucks/Chassis, Sport Utility Vehicles & Vans – 1st Option"; and

WHEREAS, Route 23 Automall LLC is an awarded vendor under said cooperative contract, which is effective June 19, 2026 through June 18, 2027, pursuant to Bergen County Board of County Commissioners Resolution No. 572-26 dated May 5, 2026; and

WHEREAS, the Borough is authorized to make purchases through properly awarded cooperative purchasing agreements in accordance with applicable New Jersey public procurement laws and regulations; and

WHEREAS, the Chief Financial Officer has certified, or shall certify prior to the issuance of a purchase order, that sufficient funds are available for this purchase.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Kinnelon, County of Morris, State of New Jersey, as follows:

1. The purchase of one (1) 2026 Ford F-150 4x4 SuperCrew Cab XLT from Route 23 Automall LLC, pursuant to Quote ID KINNW3L2 dated August 12, 2026, is hereby authorized in an amount not to exceed \$67,383.40.
2. The purchase shall be made through the Bergen County Cooperative Purchasing Program under Bergen County Bid No. BC-Bid-24-43.
3. The Mayor, Borough Administrator, Chief Financial Officer, Qualified Purchasing Agent, Borough Clerk and other appropriate Borough officials are hereby authorized to execute any documents and take any actions necessary to effectuate this purchase.
4. This Resolution shall take effect immediately.
