Old Business:

Morris County Historic Preservation Trust (large grant money): John Cannie-1) Had preconstruction meeting. Tom helped immensely. Contractor wants to start work and move fast. Needs to get all permits first and then hopefully start in 90 days. 2) Everything has to be out of the building or covered with plastic by June 20th. The artifacts will stay under cover. The furniture is going out starting tomorrow at 6am by DPW-Tom will meet them there; Laura will be there @7 and John at 8. Leave the kitchen items there. Take display cabinets out of the garage and put in trailer. Put everything in the middle of the room and cover. Put Dr. Miller's carpets under cover with plastic. Fire truck can stay. 3) Gardening can continue while work is being one. If there is an outdoor event planned, contractor will put up a cone at the porch to keep people off. 4) Next site review and construction meeting on July 9th, then every 4 weeks, plus an inspection every 2 weeks by Margaret (do not speak to contractors directly, only to Margaret or Craig).
