Morris County Historic Preservation Trust (large grant money): Tom Kline-1) Results of MEGA test-majority of circuits failed. Should rip out all sheet rock and rewire building. John has plotted all circuits showing which are good/not good. Might not need all going forward. Maybe can charge some repairs to insurance. John/Tom met with Margaret to discuss options. Just missed 2023 grant applications-museum would have to be closed for a year unless alternate funding options can be found. Tom will attend Mayor & Council meeting Thursday nite to present situation. Margaret will present flood, fire and electric repairs as separate options. Is it possible to re-wire without taking down sheet rock? If not, where would collection go? Need dry spot (Glenn Sisco school?). 2) DPW took up 20% of tiles-what happened to them? 3) There are 39 circuits; not all are good and can maybe abandon some. Hopefully can charge (some) electric work to insurance. 4) Try 'other people's money' to fix-Morris County Trust, State of NJ Historic Preservation Trust, maybe Open Space funds. 5) Probably more manpower work in attic than in main part of building. 6) Tom will outline what is known so far once he gets info from Margaret.

Morris County Heritage Commission History Re-Grant Program (small grant money): Only Jim and Tom attended workshop. Need to go thru suggestions from CAPES report and try to put \$\$ amounts on all their ideas. Tom will prioritize those worth investigating-schedule workshop for May to discuss and assign to various committee members; then pick one project for the grant money.
