Morris County Historic Preservation Trust (large grant money): Tom Kline-1) Museum has heat! Asbestos remediation is next, then will try and resolve electric issue (meeting next week).

- 3) Plumber smelled gas by meter; called PSEG who were taking care of it today. 4) Proposal from Margaret-will insurance pay? Will send in and see. 5) Insurance will only pay for electric due to result of their testing-if museum has to be re-wired, insurance will not pay. 6) Tom would like to get cost of Megger test and a quote for re-wiring from Harry Van Riper. 7) Remove sub-panel and run everything from basement? 8) Leave door open in kitchen so pipes don't freeze.

Morris County Heritage Commission History Re-Grant Program (small grant money): Janet Pardo at CAPES called Tom-There is a shortage of CAPES operators. She wanted to get an idea of what the committee was actually going to do with the grant money. She can come to make a report but not anytime soon; more likely next year. Final voucher was sent out early in error-Laura will call Nicholas Palatucci. Should grant money be sent back and try again next year?
